took wrong car	\$10 + compensation to PCC for lost revenue and for costs incurred by affected member for alternate transportation
no show for reservation	100% of hourly rate
NSF (no sufficient funds)	\$15
investigation of parking or speeding tickets	\$10 + cost of violation(s)
administration fee for use of 407 toll road	\$2.50 (no charge if office is notified of use)
fee for return of impounded or towed vehicle	all accumulated charges + staff time
use of vehicle without reservation	\$10/hour + \$1/km + compensation for affected member
return of vehicle with less than ½ tank of gas	\$10
smoking	\$25
doors left unlocked	\$10
lights left on/battery dead	\$10 + compensation for affected member & staff time
windows left open	\$10
logbook incomplete	\$10

messy car/cleaning fee	\$10 compensation for affected member + cleaning fees
lost key	\$25 + lockbox replacement costs (if applicable)
failure to record vehicle damage (e.g. paint scratches, dents, etc.) during <u>before and after trip</u> vehicle inspection	\$25 admin fee and/or partial or full payment for vehicle repairs and/or the cost of lost revenue due to scheduled vehicle repairs
Notes: <ol style="list-style-type: none"> <li>1. Memberships are transferable</li> <li>2. Membership loan is similar to a security deposit – fully refundable on cancellation of membership</li> <li>3. Co-op pays for gas. Co-op policy is to increase per km rates by ¢1 for every ¢10/litre increase in gas prices - increases will be announced</li> <li>4. Cancellation charges only apply if vehicle is not rebooked by another member</li> </ol>
